
NCAA Office of Inclusion

THE TEXT OF TITLE IX

No person in the United States, shall on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any educational program or activity receiving federal financial assistance.

HISTORY OF TITLE IX AND ATHLETICS: A ROLLER COASTER!

1970s:

- ▶ Amazing participation growth for girls and women
- ▶ Association for Intercollegiate Athletics (AIAW) prospers
- ► NCAA fights Title IX and engages in hostile takeover of Association for Intercollegiate Athletics (AIAW)

1980s:

- Alaw closes its doors.
- ▶ Supreme Court Case Grove City v. Bell results in no Title IX for athletics for half of the decade.
- Athletics departments merged and women leaders lose power.

HISTORY OF TITLE IX AND ATHLETICS: A ROLLER COASTER!


- 1990s:
 - ▶ Federal legislation: Equity in Athletics Disclosure Act
 - ►NCAA Gender Equity Survey and NCAA Gender Equity Task Formed
- 2000s:
 - ▶ President Bush's Commission on Opportunity in Athletics poses challenge to Title IX.
 - ▶ Emphasis on sexual harassment/violence.
 - ▶Interpretation of "sex" in the law to include gender.





A. Financial Assistance

- Total amount of athletic aid must be substantially proportionate to the ratio of male and female athletes.
- Example:
 - ▶ 45% of athletes are female, then 45% of scholarship money should be awarded to female athletes
 - Not applicable at D-III level where no athletic scholarships granted.

B. Effective Accommodation of Students' Interests and Abilities

- "Three-Prong Test"
- 1. Opportunities for males and females proportional to enrollments.

- 2. History and continuing practice of program expansion responsive to the developing interests and abilities of the underrepresented sex.
- 3. Interests and abilities of underrepresented sex have been fully and effectively accommodated by the present program.

C. Benefits, Opportunities and Treatment

- Equipment and supplies
- Scheduling of practice and competition
- Travel and per diem
- Opportunities for coaching and academic tutors
- Assignment and compensation of coaches and academic tutors
- Locker room, practice and competitive facilities
- Medical and training facilities and services
- Housing and dining facilities and services
- Publicity
- Support services
- Recruitment of student-athletes

TITLE IX AND ATHLETICS

A. Participation: The Three Prongs (must comply with one)

- 1. Opportunities for males and females proportional to enrollments.
- 2. History and continuing practice of program expansion responsive to the developing interests and abilities of the underrepresented sex.
- 3. Interests and abilities of underrepresented sex have been fully and effectively accommodated by the present program.
- **B. Financial Assistance/Scholarships (1%)**
- C. Treatment/Benefits (The Laundry List)
 - 1. Compare overall men's and women's sports programs.
 - 2. Focus on student-athlete impact. (uniform example)
 - 3. Title IX does not care from where the money comes!
